Release, Waiver of Liability and Indemnity Agreement

The undersigned hereby enters their child in The Christian Center Youth Bowling Program and desires that said child be instructed and enrolled to participate in practices, games and related activities carried on by said program. The undersigned recognize and acknowledge that there are certain risks of physical injury present but in consideration hereof hereby agree to assume the full risk of any such injury, including death, damages or loss which may be sustained by said child as a result of participation in any and all activities connected with or associated with the Program.

In further consideration hereof, the undersigned, their heirs, executors, administrators and assigns, hereby release, waive, discharge and covenant not to sue The Christian Center Youth Bowling Program Committee its officers, directors, committee members, agents and employees (hereinafter referred to as "releasees") from any and all liability to the undersigned, their heirs, executors, administrators and assigns, for loss or damage of whatsoever kind or nature on account of or arising out of any injury to the person or property or resulting in the death of the child referred to above, whether caused by the negligence or wrongful conduct of the releasees named herein or otherwise, while said child is participating in or in attendance at any game, practice, fund-raising event or award trip, on Christian Center property or elsewhere, including but not limited to any such injury, property damage or death incurred while traveling to and from any such event.

In further consideration hereof, the undersigned, their heirs, executors, administrators and assigns, hereby agree to indemnify and hold harmless the releasees named herein from any and all loss, liability, damage or cost that they may incur due to any such injury to the person or property or resulting in the death of said child, as stated above, whether caused by the negligence or wrongful conduct of the releasees named herein or otherwise.

In case of accident or illness, the undersigned hereby consent to emergency medical treatment for said child provided by qualified medical personnel. The undersigned have read and fully understand the above Release, Waiver of Liability and Indemnity Agreement, and further agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made. • I also give my permission for my child's picture to be used in Christian Center publications.

Juniors / Majors bowl 3 games from 10:30am - 12:45pm and the cost is \$6.00 / week
